Pursuant to the Note Issuance Agreement and Notes, Debtor has pledged to Secured Party as Collateral all of its rights to the principal corpus of the United States Treasury Bonds registered under CUSIP 912810QZ4. The terms of this Collateral Pledge and Security Agreement are reflected in the agreement between Secured Party and Debtor. Langpan Mining Co (Pty) Ltd have assigned \$3,500,000 to RWE Supply & Trading GmbH to support the obligations under the Special Performance Guarantee (SPG) Facility between Newpoint Reinsurance Company Limited, Mantengu Mining Ltd & its subsidiary Langpan Mining Co (Pty) Ltd and RWE Supply & Trading GmbH.
